Dear Sunnybrook Bond Holder:

Welcome to the 2011 season! This is your 2011 membership notice, which includes the 2011 User Fee Schedule that was approved at the Annual meeting of the board of Governors on Saturday, February 26, 2011. Please note that an increase in the 2011 fees was approved to cover the increased cost of operations, including, but not limited to, an increase in the wage rate between entry level employees & returning employees, an increase in the cost of pool chemicals, and increases in utility rates. While we understand that financial times are difficult for many, we appreciate your understanding that this modest increase in the fees is necessary to avoid a deficit in the operating budget of the facility.

The Sunnybrook by-laws require that your 2011 fees are DUE IN FULL by April 30, 2011

Guests: Guests are welcome, and must comply with the Club rules. Guest fees must be paid at the Club entrance. A Club member must accompany all guests. Currents fees are \$3 on weekdays; \$5 on weekends and holidays; and \$2 anytime after 6 p.m. Members and renters may purchase guest pass cards at a reduced rate, currently 15 visits for \$50. The passes are non-refundable and valid only during the season purchased.

It is important to act as soon as possible to avoid payment of dues or assessments for the upcoming season. A bond cannot be liquidated until the Membership Chair receives your written notice stating that it is your wish to liquidate your bond. The bond needs to be signed and dated on the back and submitted with your letter. It is very important to communicate your desires to liquidate your bond prior to the April 30 deadline. Any bond liquidation request received after the April 30 deadline may be subject to the payment of the current year's dues.

Each bond shall be redeemed in the chronological order in which the memberships terminate and after payment has been received from an incoming replacement member. This process is reconciled after the opening of the season, therefore, reimbursements are generally mailed out in late June - early July.

Please understand that there is a possibility that your bond will not be sold this season; therefore, you may need to wait until the ensuing season before it is sold. Your patience and understanding is greatly appreciated.

Membership Dormancy

A bonded member may elect not to join Sunnybrook in any given season without liquidating their bond by checking the appropriate box on the Bonded Membership Application. The annual fee to make a membership dormant is \$60.

Swim Team and Dive Team Information

Swim Team and Dive Team registrations are handled through the Sunnybrook website. Participants must be either Bonded Members or Full Summer Rental Members.
